  - A. President Nithya Kasireddy
- 1. Guests: Tulane Mobile App demonstration from the Technology services (Rescheduled for April 23rd GAPSA meeting)
  - 2. Downtown dining meeting update
  - Contact Alyssa Fears if interested in being part of a focus group Survey on future for downtown dining area soon.
  - 3. GAPSA 2018-2019 summary:
    - 1) One of the major GAPSA goal was recognizing graduate organizations: See attached document GSA structure.pdf
      - a) Interdivisional graduate diversity organizations (phase 1)

Recognized directly under GAPSA. GAPSA president organized meeting with all division presidents a few weeks ago.

b) Division specific graduate organizations (phase 2)

Currently 2 groups officially recognized by GAPSA. 1.3% of the GAPSA budget goes to funding these groups. Starting cap of funding requests are \$1000. Nithya would like to increase this cap and move \$10,000 from CEF funds to this pool for these groups. Money is there, just need to work out how to move accessible funds around with approval. Potentially propose that rollover funds be possible. Perfect time now that there are only 2 (maybe 3) groups approved; goal is potentially allowing these groups to be self-sufficient funding-wise.

- 2) Second major GAPSA initiative graduate and professional students needs assessment survey (See attached document <u>GAPSA survey map.JPG</u>)
  Collaborative effort. Wants to be a priority for GAPSA next year. Public Health has already drafted a student assessment poll, could share draft with GAPSA.
  - 3) Overall, GAPSA has continued to build and foster good relationships with various partners on campus this year.

  - B. Executive Vice President Davette Gadison
  - i. Sexual Assault Awareness Month April 16 (downtown panel) A Tuesday. 2-3:30 pm suggested time. Panel: Catherine Yockey (victim services), Meredith Smith (Title IX), Margaret Reynolds (new downtown/graduate student health promotion specialist)

Food option suggestions? Vegetarian for sure; Asian vegetarian; gluten free and vegan options; nut free

ii. April 12 8pm to 12 am - Spring Mixer Over 500 people RSVP'd so far. At the Cannery. Purchase drink tickets before entering the venue. Option to purchase more if needed. iii. Summer Merit Grant - GSSA There are concerns about amount of grants offered this year vs last year (particularly SLA). More discussion about this issue with groups needed.

### C. Downtown Vice President - Alyssa Fears

- i. (5 min) Meeting with Downtown Police: Communications to Students Issues with notification process/timeliness about the recent shooting that occured downtown was brought up. For future: better notification/email program that is now running; send Alyssa thoughts on what should happen in the next 6 months that would demonstrate that the downtown police is committed to perception of student safety. 6001 SOM March 21 12-2 pm meeting to discuss this incident and what can happen in future/solutions to these problems.
  - ii. (1 min) Graduation Regalia- Subsidization, Generic Black Robes (cheaper option purchase only, but this option is not/cannot be advertised), OISS Emergency Fund Propose that other divisions could possibly help fund their graduating students?
  - iii. (3 min) IGDOs
    - a. IGDO Bylaws: Vote Tabled until some edits are made from suggestions/issues raised by assembly.
    - b. New Organizations/Events
      - New IGDO TU Alianza Graduate Association
      - WiSE+ Event funding \$1515 for food and appreciation certificates for mentors/mentees at their Appreciation Picnic.
      - ISGSA Event funding For their New Year's bash that includes cultural performances from graduate students. \$2000 requested. \$1400 confirmed, \$600 conditional based on if other funding is received.

Motion to vote for both amounts (\$1515 for WiSE; up to \$2000 for ISGSA) which was seconded. Funding requests unanimously approved.

Issue with bylaws brought up by assembly: 1) Solid \$ amount limit should not be listed in bylaws because of inflation - rather, maybe say that the Finance committee or IGDO committee will set this limit at the beginning of each fiscal year/open based on the total available funds to change by the committee. A graduate student from the current IGDO ISGSATU suggested that the funding needs should also be considered based on the size of the IGDO group membership and their event attendance.

2) Minutes not available to be public or committee members - Will be added to bylaws that they will be on the GAPSA website 3) Potentially add a non-voting member (or maybe more) to committees/GAPSA assembly to represent these groups (a liason - Could potentially partner with ISAB); critical that there are multiple because of the diversity of the diversity groups.

What would you do different with events next year? There are concerns that events are centered around alcohol. - Ben will do his best to follow in Davette's footsteps. Wants everyone to feel welcome, and it's his first time to hear that critique so he wants other events besides mixers to come about and divisions to voice their concerns more in assembly meetings.

Position on making the survey move forward? - First issue was the funding, and that took awhile to hash out in the fall. Need to find partners in the school and as of now, all but 1 division is represented. Wants something broadly applicable but also able to reach to the unique situations in each school. Wants a survey that allows for a non-response so if a question does not apply to you, you can skip it. Envisions 2-prong survey to develop in the fall. Only in the last month have all but 1 division agreed. Slow movement at first because of lack of representation with divisions and improved communication.

Staying on with other positions? - GAPSA will be his only exec position.

# Downtown Vice President Nominees

"I've been at Tulane University for 5 years, first completing a Master's of Public Health in Tropical Medicine (MPH&TM) at the School of Public Health, and currently a doctorate in Biomedical Sciences within the School of Medicine. I am interested in a second term as Downtown Vice President because I have enjoyed making a difference in the lives of our downtown graduate students. I was elected to fill the vacancy after our first DVP resigned, and I couldn't have been more excited to advocate for the downtown community I so know and love. Within the past 6 months as DVP, I have helped to establish a quarterly travel stipend for students completing research at the Primate Center, led the initiative to replace the broken and worn water fountains in the School of Medicine, directed efforts to emulate consistent Uptown events on the Downtown campus such as Downtown Coffee/Pizza with a Cop featuring TUPD officers and Downtown Donut Days with OGPS, and spearheaded the new Interdivisional Graduate Diversity Organization (IGDO) initiative. If re-elected, I plan to continue all of the above efforts, strive to establish a weekly Downtown Newsletter, foster a true sense of community among graduate students downtown through unifying events, and continue to advocate for all graduate students campus-wide."

Elected in September after the former DVP resigned, this list represents the work I've done over my 6 months as DVP.

### 1) Downtown News

- ⇒ Created an email group with the program managers of (hopefully) every program with students downtown to be able to distribute downtown-pertinent information in a timely manner
- ⇒ Continue to work on a true Downtown Newsletter with Technology Services

### 2) TNPRC Shuttle

- ⇒ Solicited letters of support for a shuttle service from the New Orleans campuses to the Primate Center from the Director of the Primate Center, Dr. Jay Rappaport, and Director of Education and Training, Dr. Monica Embers.
- ⇒ Succeeded in helping to establish a quarterly stipend for travel to students worth approximately \$4,000 yearly

### 3) Physical Facilities Committee member

- ⇒ Initiated the process to replace the water fountains in the School of Medicine (work to do so is underway)
- 4) Downtown Holiday Craft Day
  - ⇒ Joint effort with Nithya (President): held a crafting event during the month of December as a Study Break during finals

### 5) Graduate Council member

- ⇒ Scheduled and orchestrated a Downtown Donut Days in conjunction with the Office of Graduate and Professional Studies to increase their visibility on the downtown campus
- ⇒ Downtown Donut Days was held on January 23<sup>rd</sup>, and they have reached out to plan another in the 2019-2020 academic year

- 6) Student Health Advisory Committee member
  - ⇒ Proposed that information disclosed in the meeting be published on the student health center website and on signs within the facilities, as some of that information was not readily accessible to students
- 7) Safety Committee member
  - ⇒ Led efforts to establish Downtown Coffee/Pizza with a Cop, now an ongoing effort
  - ⇒ Dates held: November 1<sup>st</sup>, December 11<sup>th</sup>, 2018; February 14, 2019

  - ⇒ Met with TUPD to voice concerns about how the shooting downtown on February 17<sup>th</sup>, 2019 was handled. Outcomes include: increasing support for a downtown newsletter and communication system, Downtown Town Hall March 21<sup>st</sup>, 2019 from 12:00 pm-2:00 pm
- 9) IGDO Committee
  - ⇒ Development of Bylaws from meetings with Student Affairs
  - ⇒ Formation of the IGDO Committee consisting of the Vice President (or their proxy) from each GAPSA Division
  - ⇒ Founding of two Interdivisional Graduate Diversity Organizations (WiSE, ISGSATU)
  - ⇒ Creation of recognition and event funding forms through OrgSync
  - ⇒ Construction of training materials and the individual training of each new organization on policies and procedures

If re-elected, I would strive to continue many of these new initiatives, as well as accomplish the following:

- ⇒ Create a true Downtown Newsletter, sent out on a weekly basis, with pertinent information for students on the Downtown campus
